In the event one of the events contemplated above occurs, all deposits money shall be returned in full. PRICE QUOTE - HST and Gratuities (fifteen percent) Is not already included in our price guotes and will be calculated and added to your total. CANCELLATION POLICY: Should you have a change of heart and change your mind call or email us within 10 days of booking and we will gladly cancel your booking. Should the person booking the party have to postpone the booked entertainment, it will be re-scheduled for another date and time suitable to all parties involved. Should the person booking the party cancel the performance after 10 days from booking date, the full fee will be due and payable upon cancellation.
